

**ORDER No. 70/2023**  
**OF THE RECTOR OF THE RZESZÓW UNIVERSITY OF TECHNOLOGY**

**dated 25 September 2023**

**Amending Order No. 36/2019 of the Rector of the Rzeszów University of Technology of 17 July 2019 on the introduction of the Rzeszów University of Technology Regulations on Benefits for Students at the Rzeszów University of Technology**

Pursuant to Article 95(2) of the Act of 20 July 2018. – Law on Higher Education and Science (i.e. Journal of Laws 2023, item 742, as amended), I order as follows:

**§ 1**

The Rzeszów University of Technology Student Benefits Regulations of 17 July 2019, introduced by Order No. 36/2019 of the Rector of the Rzeszów University of Technology of 17 July 2019 on the introduction of the Rzeszów University of Technology Student Benefits Regulations (hereinafter: the Regulations), are amended as follows:

1) § 17 sec.4 is replaced by the following:

"4. The Scholarship Appeals Committee shall be composed of students representing all faculties of the university, one representative from each faculty, a representative of the PRz Student Government, and PRz employees in the number of four persons, including at least three employees of the PRz organisational unit having as part of its responsibilities the handling of student benefits. The majority of members shall be students.";

2) in Annex 3 to the Regulations - Method of documenting and rules for determining the income of a student's family:

a) § 2 sec.3 point 6 shall be replaced by the following:

"6) a certificate issued by a social assistance centre or by a social services centre on the use of social assistance benefits by the student or by members of his/her family in the year of submission of this application;"

b) § 12 sec.1 point 4 shall be replaced by the following:

"4) loss of pre-retirement benefit or pre-retirement benefit, teacher's compensation benefit, as well as pension or disability pension, survivor's pension, social pension, parental

supplementary benefit referred to in the Act of 31 January 2019 on parental supplementary benefit (Journal of Laws of 2022, item. 1051), or a cash benefit granted on the basis of the principles set out in the Act of 8 February 2023 on a cash benefit due to family members of officers or professional soldiers whose death occurred in connection with service or undertaking off-service activities to save human life or health or property (Journal of Laws item 658); ',

c) § 13 sec.1 point 4 shall be replaced by the following:

"4) obtaining a pre-retirement benefit or pre-retirement benefit, a teacher's compensation benefit, as well as an old-age or disability pension, a survivor's pension, a social pension, a parental supplementary benefit referred to in the Act of 31 January 2019 on parental supplementary benefit, or a cash benefit granted under the rules set out in the Act of 8 February 2023 on the cash benefit due to family members of officers or professional soldiers whose death occurred in connection with service or undertaking off-duty activities to save human life or health or property;"

## **§ 2**

I entrust the pro-rector for student affairs with the supervision of the implementation of the order.

## **§ 3**

The remaining provisions of Order No. 36/2019 of the Rector of the Rzeszów University of Technology of 17 July 2019, as amended, remain unchanged.

## **§ 4**

The Order shall enter into force on the date of signature.
